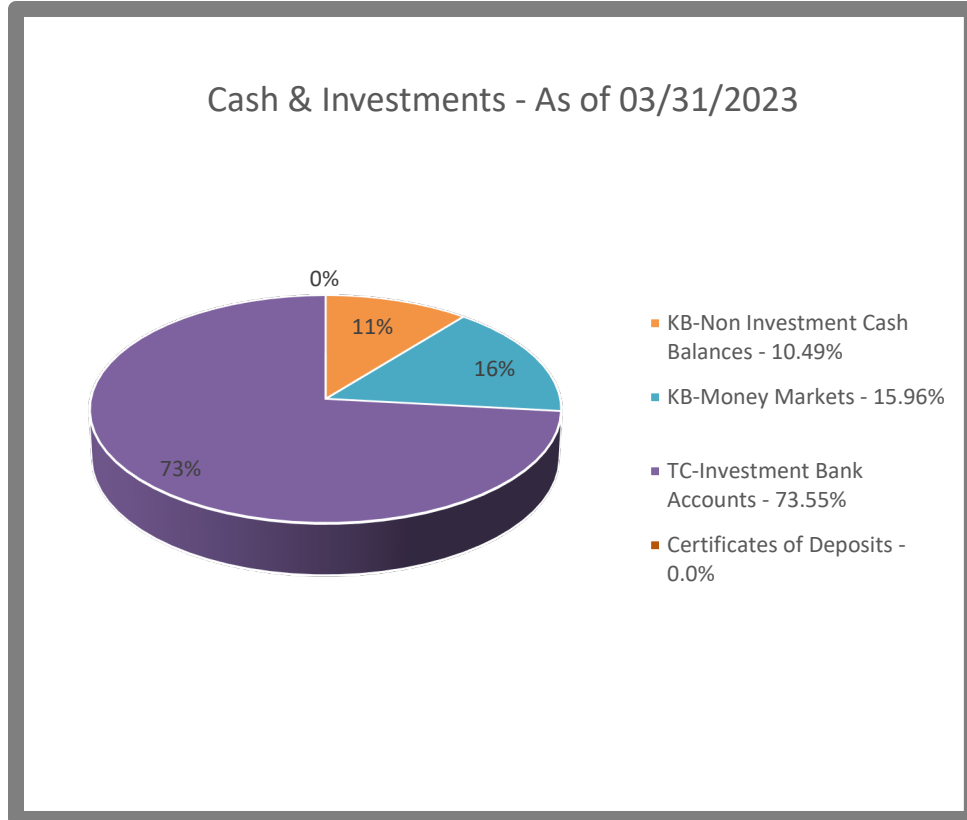

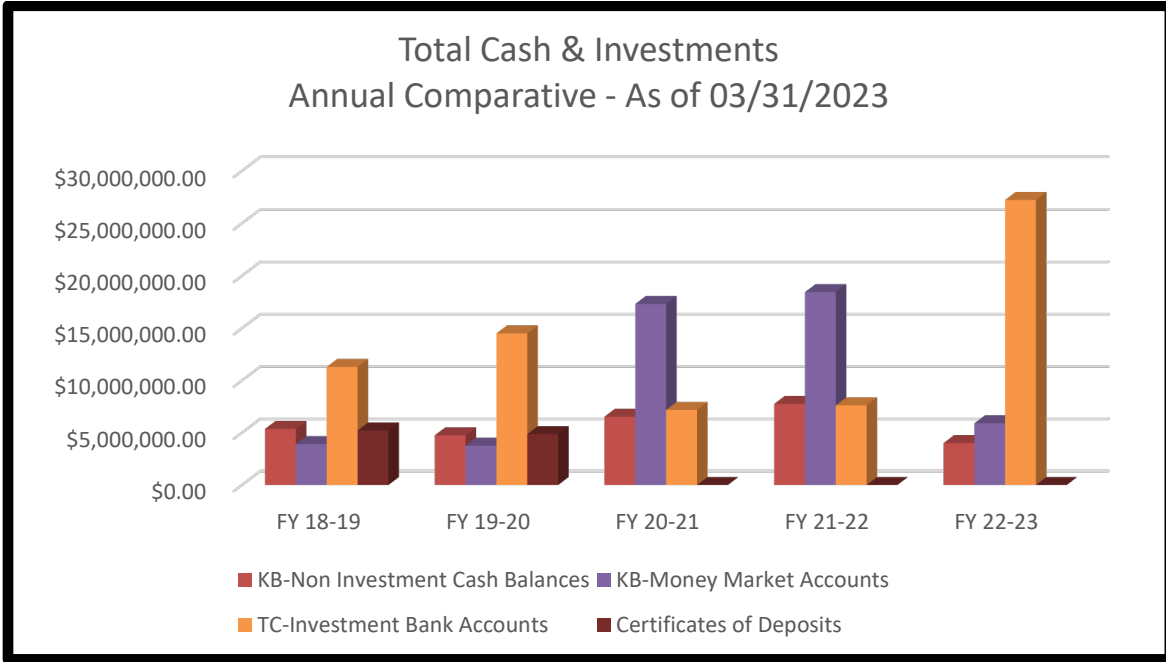

Interest rates are slowly increasing, and Finance will be moving money from Kleberg Bank to Texas Class to take advantage of the slight increases in interest rates. The average monthly yields for the prior fiscal year through the 2nd Quarter of FY 22-23 for Texas Class are below:

- January 2022 through March 2022 - .0965% to .2857%
- April 2022 through June 2022 - .4720% to 1.1577%
- July 2022 through September 2022 – 1.6392% to 2.6788%
- October 2022 through December 2022 – 3.2287% to 4.3170%
- January 2023 through March 2023 – 4.5742% to 4.8597%
